Section 3: HAZARDS IDENTIFICATION

### EMERGENCY OVERVIEW

WARNING. Combustible. Keep away from heat and flame. Harmful or fatal if swallowed. Vapor harmful. Harmful if absorbed through skin. Can cause nervous system depression. Amber-brown liquid with solvent odor.

Primary Route of Entry: Skin contact/absorption, inhalation, eye contact

#### Section 4: FIRST AID MEASURES
